What if a provider offers services under multiple provider types, including services assigned to multiple members of the Provider Network team?

If a provider offers a broad spectrum of services that includes provider types assigned to multiple Provider Network managers, the provider should notify Summit Community Care of which county they consider primary. We will assign a Provider Network manager in the provider's primary county to serve the their needs for all counties and provider types.
