

Third-Party Bypass List for Commercial insurance

In most instances, when submitting claims where third-party liability (TPL) exists, care providers must adhere to the coordination of benefits guidelines which require submission of claims to the primary insurer prior to submission to Summit Community Care as a secondary payer.

However, for eligible members with dual Commercial insurance and Medicaid coverage, Summit Community Care maintains a Commercial *Third-Party Bypass List* that identifies service codes and specialties for which no TPL information will be required.

The Commercial *Third-Party Bypass List* below is effective as of February 1, 2024. Note that Summit Community Care may retroactively review these services. Therefore, care providers must maintain TPL information.
